

**Munising Township Regular Board Meeting Minutes**  
**November 7<sup>th</sup>, 2016 7:00 p.m. – 7:40 p.m.**

**Roll Call:**

**Supervisor Wilson opened our November 7<sup>th</sup>, 2016 meeting at 7:00 p.m. leading us with the pledge.**

**Public Comment:**

Deb Carlson requested a streetlight on Olson Road - children are picked up by the school bus in the dark. Dan asked her to bring it up at the next meeting when Trustee Howard is present because she is our streetlight person.

**Approval of Minutes:**

Motion Treasurer Fulcher/Second by Trustee Balko that we **approve the October 3<sup>rd</sup>, 2016 minutes.**  
Motion carried.

**Clerk's Correspondence:**

Information from Kathy Reynolds regarding Redevelopment Ready Communities (RRC) training – I forwarded that on to several persons on our planning and zoning committees. Marianne Laskay plans to attend the training in Muskegon on the 10th. MTA's "New Officials Training" – Classes in December and January (U.P.).

**Supervisor's Correspondence:**

Received \$5,000 (pass-through money) and \$3,500 from Sault Ste. Marie Tribe Chippewa Indians. Received our State Revenue Sharing monies - \$34,482. Received monies from Cable America and Accident Fund. Charter is adding 3 channels. DEQ putting a bridge in off Miners Road (road gated). DEQ proposing to put in a parking area for 6 cars, 1 ADA, and 1 bus at Wagner Falls. Proposed schedule for next year from Forest Service includes McKeever cabins.

**Requested Items:**

A: Fire Department – Assistant Fire Chief Balko mentioned Chief Anderson applied for another grant for air packs.

**Clerk's Report:**

Election Day is tomorrow (November 8th)! AV Ballots Issued this election is 235 with 92% returned so far. Lynn Bright, from Burnham & Flower Insurance would like to meet with us on November 30th at 10:00 a.m.

**Supervisor's Report:**

Dan delivered a check to SuperiorLand Gas Co. for propane to heat Shingleton Hall this winter. Fahrner will start work right away in the spring. Dan met with Tom Mosley regarding blight and housing issues on Olson Road and Carlson Road. Tom left paperwork that will help those persons get assistance. SORVA wanted to run ORV trail through Township property but we don't have the room. Incident at the Fire Hall with foam getting down into the traps and holding tank ended up not being an issue. Tri-County Septic came and pumped tanks and everything was fine. Dan took signed GIS Agreement to Pam, the Alger County Treasurer. GIS will be implemented early this winter, and then the board can decide which layers to add. Faxed Fire Protection Survey to the State.

**Unfinished Business:**

A: Consider request from Chamber of Commerce – Motion Treasurer Fulcher/Second Trustee Balko to **donate \$4,000 to Alger Chamber of Commerce.** Motion carried.

B: Consider request from Greg Pond (Munising Hockey Association) – Greg is requesting up to \$5,000 to update boards and glass. Board agreed to table until spring (March).

**New Business:**

A: Consider request from SORVA – not present.

B: Consider Assessor's Contract – A resolution was offered by Trustee Balko and supported by Treasurer Fulcher to **accept contract for assessing services.** Roll Call Vote: Wilson-yes, Fulcher-yes,

Balko-yes, Willson-yes, Howard-absent. Four yes, no nay, one absent – Supervisor Wilson declared the resolution passed.

C: Consider Budget Amendment – A resolution was offered by Trustee Balko and supported by Supervisor Wilson to **amend road budget as suggested**. Under Roads, “Bond Payment”, add \$20,000, and under Roads, “Contractual Services”, subtract \$20,000. Roll Call Vote: Howard-absent, Balko-yes, Wilson-yes, Willson-yes, and Fulcher-yes. Four yes, no nay, one absent – Supervisor Wilson declared the resolution passed.

D: Consider Federal Holidays – Clerk Willson/Second Treasurer Fulcher **we close our office for all Federal holidays**. Motion carried.

Trustee Balko thanked Supervisor Wilson and Treasurer for their years of service and invited everyone to join us for coffee and cake after the meeting.
