

**Munising Township Regular Board Meeting Minutes**  
**June 6<sup>th</sup>, 2016 7:00 p.m. - 7:50 p.m.**

**Roll Call:**

Board Members Present: Supervisor—Dan Wilson, Clerk—Patty Willson, Treasurer—Bonnie Fulcher, Trustee—Lisa Howard, Trustee—Selina Balko. **Supervisor Wilson opened our June 6th, 2016, meeting at 7:00 p.m. leading us with the pledge.**

**Public Comment:**

Tom Dolaskie—Concerned about the condition of Miller Road and reason why it is not paved.

**Approval of Minutes:**

Motion Treasurer Fulcher/Second by Trustee Howard to approve the May 2<sup>nd</sup>, 2016, minutes with a spelling correction of Trustee Willson, instead of Wilson, under New Business. Motion carried

**Supervisor's Correspondence:**

Cable America; Department of Transportation—Wants to grade a corner on Ken McPherson's lot to repair a railroad crossing; UPPCO; MTA's springtime meeting is in Harris this year (Dan attending this week (6/7 – 6/9) then he is taking an assessors class in Escanaba (6/10); Check from Charter; and Bowman Gas Company, n/k/a Superiorland Propane.

**Clerk's Report:**

We had a 42% turnout on Election Day (5/3-School Election). Selina and I completed Accident Fund's annual Worker's Compensation Audit. We printed and sent out absentee ballot applications to the 81 voters on the permanent AV list. The actual ballots for the State Primary Election (held August 2<sup>nd</sup>) will go out this month. Auditors are here this week.

I will be attending election training the end of June (29<sup>th</sup> and 30<sup>th</sup>). There will also be training coming up for our election inspectors sometime in June or July (no date confirmed). An election commission meeting will be held in July for the August election.

**Supervisor's Report:**

ACRC gave us a proposal for Lost Lake Road, \$56,486, and would like to see that road on the road priority list. The ballot language for our firetruck millage went to the county and will be on the November ballot due to a missed deadline. Spring Clean-up went well. We had a 40 yard box in Shingleton and a 40 yard box at house on the corner on H15/H58. Both boxes filled by 9:00 a.m. Wood Island Landfill had no extra boxes available and no extra drivers to empty the full boxes so approximately 90 residents were directed to the landfill. We collected approximately 50 tires. Additional box going to H15/H58 next week (6/16) to take care of remaining debris (couch, chair, tires, and trash) before turning homeowners over to the Health Department. Roger ran dust control and it went well... almost ran out though. We typically use 38% (with the exception of using 35% last year) because it holds better. We barely had enough to put down at the park. We've supplied Anthony Street for Grand Island Twp. for a few years. Dan will suggest to Grand Island Twp. that perhaps AuTrain Twp. can take care of Anthony Street in the future since AuTrain gets 3 trucks and us, only 2. Roger said Riley Road wasn't done because it's not up to gravel standard. There is "COM" on the Shingleton tower and may be November before it is operational. Johnson Brothers finished repairs to the boardwalk.

**Unfinished Business:**

A: Consider 2 bids on basketball courts (Seal King (\$15k) and Farhner (\$19k)): Motion Trustee Howard/Second Treasurer Fulcher to **award job to Farhner**, the ones who originally completed the job 15-20 years ago. Farhner specializes in court-type work and will blow off the surface, level off birdbaths, re-seal, and re-paint. Motion carried. A resolution was offered by Trustee Howard and supported by Trustee Balko that the township pays Farhner (\$19,668.86) **using all the monies in the recreation fund and the remaining balance owed from the recreation improvements fund** for the resurfacing of the basketball courts. Roll Call Vote: Willson-yes, Balko-yes, Fulcher-yes, Howard-yes, and Wilson-yes.

D: Consider Budget Amendment: A resolution was offered by Trustee Howard and supported by Trustee Balko **we amend budget** as suggested. Motion carried. Under Building and Grounds, Miscellaneous subtract \$4,000.00, and under Township Clean-up add \$4,000.00. Roll Call Vote: Fulcher-yes, Howard-yes, Willson-yes, Balko-yes, and Wilson-yes. All yes, no nay, Supervisor Wilson declared the resolution passed.
